#1-The **No Hassle Replacement™ limited warranty** provides a new equivalent replacement unit should the compressor, covered coil or heat exchanger fail during the No Hassle period. Split system units must be matched with a Heil indoor coil or fan coil. Written authorization from your Heil distributor is required prior to replacing any unit. This warranty is a supplement to the standard product limited warranty. Restrictions apply. Go to Heil-HVAC.com to view the most current and complete Warranty Certificate for further details.

#2-Heil gas and oil furnaces and R410A-based air conditioners, heat pumps, coils and small package products carry a **ten (10) year limited warranty on parts**, including compressor and coils to original homeowner, when installed in an owner-occupied single-family residence and properly registered within ninety (90) days after original installation. (See Warranty Certificate for registration instructions. Registration not required in all jurisdictions.) Otherwise, the warranty period is **five (5) years** from the date of installation. R22-based products and mini-splits are covered by a **five (5) year limited warranty on parts**. Heat exchangers carry longer limited warranty coverage that applies to original homeowners with timely registration. Otherwise, heat exchanger warranties are 10–20 years from date of installation, depending on model. Check individual listings. Restrictions apply. See Warranty Certificate for details.
